

A Code Enforcement meeting for all Block Captains will be held at 6:30 p.m.


#### 644 W. 8th Gets a Face Lift

#### 644 W. 8th cont'd.....

When Mike LaPoint purchased the 4-plex at 644 W. 8th Street in 2001, the building was in need of everything (including the physical removal by the Police of a "special" character living there before escrow could close). Mike worked closely with the Historic Preservation Officer at the time to make sure the exterior doors, railings and windows were restored to their original design. Unfortunately most of the built-in cabinets were gone but the original interior mouldings were still intact.

The building still has it's original layout of 4 one-bedroom units. It did not get split out to make more bedrooms as others of this type have had done. The interiors have all been upgraded with new kitchens, bathrooms, plumbing and electrical.

After completing the interior, Mike began to search for someone to repair his exterior bricks -- a process which proved to be quite a nightmare for him but through his perserverance he finally found someone able to do the job. Originally this brick facade was constructed by placing nails under each brick into the redwood siding and then filling between each one with mortar. Over the years, the nails have begun to rust and break off, thus leaving no support for the bricks and the mortar has gradually turned to sand. The bricks are being carefully removed, one by one, and because the mortar is virtually gone, they are coming off very clean and the majority are being reused to restore the original design of the brick facade.

This lovely 1924 four-plex is registered with the State of California Office of Historic Preservation as a significant historical structure within an historic district.

It is through dedicated efforts of individuals such as Mike that the treasures of our historic district and our City are saved. It is a costly and frustrating process sometimes but oh so worth it. Thank you Mike and all you other crazy Preservationists. Keep up the good work!
